1. One and two-family dwellings when the total building heating/cooling system input rating is 375,000 BTUs or less.
2. Alterations and repair work determined by the mechanical official to be of a minor nature.
3. Business, mercantile, and storage buildings having HVAC equipment only, with one fire area and not more than 3,500 square feet.
4. Work completed by a governmental subdivision or state agency costing less than \$15,000.

V. HOMEOWNER AFFIDAVIT

I hereby certify the mechanical work described on this permit application shall be installed **by myself in my own home** in which I am living or about to occupy. All work shall be installed in accordance with the State Mechanical Code and shall **not be enclosed, covered up,** or put into operation until it has been **inspected** and **approved** by the City Mechanical Inspector. I will cooperate with City Mechanical Inspector and assume the responsibility to arrange for necessary inspections.

VI. APPLICANT SIGNATURE

VIII. FEE CLARIFICATIONS

*ITEM #2 (RESIDENTIAL HEATING SYSTEM): This item is used for the installation of a heating system in a new residential structure. Items #10 (Gas Piping) and #18 (Ducts) SHOULD NOT be charged. Replacement systems should be itemized.

**ITEM #28: Fire suppression systems are subject to a plan review fee. Please contact our office for pricing.

IX. PERMIT STIPULATIONS

GENERAL: Mechanical work shall not be started until the application for permit has been filed and permit issued by the City of Zeeland. All installations shall be in conformance with the State Mechanical Code. No work shall be concealed until it has been inspected. The phone number for inspection requests will be provided on the permit form. When ready for an inspection, call the inspector providing as much advance notice as possible. The inspector will need the job location and permit number.

EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work.

A PERMIT WILL BE CANCELLED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CANCELLED PERMITS CANNOT BE REFUNDED OR REINSTATED.
