## **SECTION 1**

### **INTRODUCTION**

Parks, Recreation and Open Space are important elements of all communities and reflect positively on the quality of life for residents. The youth of the community are given places to go and activities to participate in that provide positive and constructive ways for them to use their leisure time. Families can find fun and inexpensive means of getting together with their friends and neighbors in a manner that builds a positive image of the community. The elderly also benefit from such programs in ways that provide for healthy and happy retirement.

A properly developed plan is representative of what people want, an imaginative projection of what might be and realistic in recognizing what is possible. It is based upon ideas that communities are for people; that change, complexity, and compromise are the essence of communities, and that planning is a means of anticipating or reacting to change.

In recent years, a more holistic approach to recreational planning has been encouraged, stretching beyond the boundaries of traditional parks to include sidewalks, linear trails, greenways, town squares, plazas and other publicly and privately owned lands. A variety of indoor facilities also serve the recreational and social needs of the public. In addition to the human benefits of recreation and open space, there are also important environmental benefits, such as water resource protection, reduced vehicular traffic, and plant and wildlife protection.

### **PLAN PURPOSE**

The purpose of this Community Recreation Plan for the City of Zeeland is to provide a logical framework to guide decisions concerning recreation facilities and services. The plan addresses current recreation issues and identifies future needs of the community and the means for meeting those needs over the up-coming five-year period. It addresses both short and long-range goals and objectives and identifies an action program by which these goals and objectives can be accomplished.



In addition, the plan serves as an educational tool to acquaint local officials and residents of the need for a sound and balanced recreation program.

The last Community Park and Recreation Plan was developed by the City of Zeeland in 2015. This new Plan has been developed both to reflect the current needs and goals of the community and to meet the Michigan Department of Natural Resources requirements for qualifying for Federal and State funding assistance. These funds are available for land acquisition and facility development and improvements to new and existing parklands.

## **PLAN SCOPE**

The scope of this plan includes the City's active and passive recreation facilities, undeveloped open space, trails, and linear "green" corridors. Recreational programming is also an important consideration; the City offers a variety of athletic, recreation and enrichment programs for persons of all ages.

The area of the plan is essentially limited to the City boundaries. However, consideration is also made of neighboring municipal facilities and regional facilities that influence use patterns. A location map follows, which illustrated the regional context of the City.

In terms of time, the Capital Improvement Schedule of this document covers development over the next five years. However, the Goals and Objectives developed to guide recreation planning may continue to be relevant for many more years to come.





## **SECTION 2**

### **COMMUNITY DESCRIPTION**

#### **INTRODUCTION**

Zeeland is a small city in West Michigan, located eight miles east of Lake Michigan; it was established in 1847 on land formerly occupied by the Odawa people. It was named after the province of Zeeland in the Netherlands, the home country of the immigrants who founded the town.

Today the city is populated by over 5,000 residents and is home to several world-renowned companies, including Herman Miller, the Howard Miller Clock Company, and Gentex.

#### **SOCIAL CHARACTERISTICS**

##### **HISTORY**

The town of Zeeland, Michigan was founded in 1847 by Jannes Van de Luyster, Reverend Cornelius Vander Meulen, and approximately 450 other Dutch immigrants. They had emigrated from the Netherlands both to avoid religious persecution and escape a faltering economy. They followed in the footsteps of Albertus Van Raalte who had settled Holland, Michigan the previous year.

##### **POPULATION**

The City of Zeeland shows a 2020 population of 5,540. Zeeland is currently declining at a rate of -0.22% annually but its population has increased by .65% since the most recent census, which recorded a population of 5,504 in 2010. Zeeland reached its highest population of 5,805 in 2000. Spanning over 3 miles, Zeeland has a population density of 1,852 people per square mile.

##### **SCHOOL DISTRICT POPULATION**

Zeeland Public School district includes 2 high schools, 2 middle schools and six elementary schools. Additionally, the district houses a successful early childhood preschool program, a year-round K-8 multi-aged school, Spanish Immersion, elementary gifted and talented, and alternative high school and an online program. The district is 94 square miles,



encompassing the City of Zeeland, a portion of the City of Holland and eight townships within Ottawa and Allegan Counties. The Fall 2018 student enrollment from K-12 was 6,230 students.

## **POPULATION DISTRIBUTION**

Age analysis is an important consideration in identifying the recreation needs of a community and provides some indication of population migration. The composition of the population of Zeeland, as determined by the 2010 U.S. Census, has the median age in the City at 38.8 years. 25.4% of residents were under the age of 18; 7.6% were between the ages of 18 and 24; 23.8% were from 25 to 44; 20.6% were from 45 to 64; and 22.7% were 65 years of age or older. The gender makeup of the city was 44.8% male and 55.2% female.

## **POPULATION BY RACE**

The City of Zeeland's population is predominantly white at 87.73%, with 5.11% indicating some other race, 3.55% two or more races, 2.26% Asian and 1.16% Black or African American as listed on the U.S. Census 2018 ACS 5-year survey.

## **OCCUPATION AND HOUSHOLD INCOME**

Households in Zeeland have a median annual income of \$43,136, which is less than the median annual income of \$61,937 across the entire United States. This is in comparison to a median income of \$39,448 in 2016, which represents a 9.35% annual growth. (Census Bureau ACS 5-year estimate). The largest industries are manufacturing, retail trade, health care and social assistance; the highest paying industries are utilities, transportation & warehousing, and construction.

## **PHYSICAL CHARACTERISTICS/RESOURCE INVENTORY**

Understanding the physical features and natural resources of the City helps to explain its historical development and guide future develop to ensure important natural resources are preserved and protected for future generations.





## TOPOGRAPHY

The topography of the area varies between flat and gently rolling. Grade changes are predominantly associated with rivers and drains, including the Macatawa ridge running northwest from the City of Zeeland into Olive Township. In general, the western areas show more elevation change, with the eastern area being essentially flat. There are no major lakes located within the area, which is characterized by numerous natural drains and associated wetlands.

## WATER RESOURCES

**Watersheds.** Nearly all the City of Zeeland is located within the Macatawa Watershed; portions of four sub watersheds exist within the City: Upper Macatawa River; Nordeloos Creek; Peters Creek; and South Branch Macatawa River. Of these watersheds, the Upper Macatawa River watershed occupies most of the land area.

## FISH AND WILDLIFE RESOURCES

Both the Huizenga Park Pond and the Black River at Paw Paw Park are a popular fishing destinations. The water features support numerous small pan fish species. There is also a large Duck and Goose population at Huizenga Park Pond and both locations are home to a variety of bird, insect, and small mammal species.

## SOILS

Soils in the City are primarily hydric soils, or non-hydric soils with hydric inclusions. Hydric soils are those which are formed under conditions of saturation with groundwater, flooding or ponding long enough during the growing season to develop anaerobic (lacking oxygen) conditions in the upper part. These soils then only support a type of vegetation found in wetlands. Wetlands are often found in association with hydric soils. Hydric soils tend to be associated with the Macatawa River basin, and in the area south of the City of Zeeland. They occur in other areas throughout the City. Non-hydric soils with hydric inclusions occur in most of the City; this means that small areas of hydric soils may be included in an area which primarily includes a non-hydric soil, but the hydric soil area is too small to map as a separate soil type. Clearly development limitations exist with hydric soils in both the construction of buildings and in locating an area suitable for a septic system. Generally, development in these areas will occur on larger lots such as occur in the



AG-Agricultural District, where sufficient non-hydric soils are present. Other areas may be suitable for construction if drained, and if public sanitary sewer is available.

## **VEGETATION COVER**

The City of Zeeland is a mature residential community and as such, many streets and yards contain mature vegetation. This includes both deciduous and coniferous trees, as well as large shrub masses. Lawrence Street, Huizenga, and Paw Paw Bridge Parks have well established shade trees and naturalized areas. The North Side Parkway non-motorized pathway runs through 1.2 miles of wooded areas, wetlands, and the waterway along the Boone Drain.

## **CLIMATE**

The influence of Lake Michigan on the climate of West Michigan is quite strong throughout most of the year. Westerly winds combined with water temperature create “lake effects”.

In Zeeland, the summers are warm and partly cloudy, and the winters are freezing, windy, and mostly cloudy. Over the course of the year, the temperature typically varies from 19°F to 82°F and is rarely below 5°F or above 89°F.

## **LAND USE**

The service area of the plan is predominantly rural in nature, with urban development concentrated in the core area of the City of Zeeland, Zeeland Charter Township and Holland Charter Township. These two townships are also exhibiting the fastest growth rates, with an increase in both industrial and residential land area expected over the planning period. It is therefore important to adequately plan for recreation and preservation.

The rural outlying areas are characterized by agricultural land, open fields, woodlands, and wetlands.

## **TRANSPORTATION**

Access to the service area from other areas along the shoreline or inland is from U.S. 31 and I-196, respectively. These limited accesses: high-speed expressways provide easy access to the neighboring metropolitan areas of Grand Rapids, Grand Haven and Muskegon. U.S. 31





provides north/south transportation along the Lake Michigan shoreline and provides numerous access points to the plan service area north of Lakewood Boulevard. I-196 runs from Grand Rapids southwest along the Lake Michigan shoreline connecting to I-94, the primary route between Detroit and Chicago. State highways serving the area include M-121 (Chicago Drive) in the south of the service area and M-45 (Lake Michigan Drive) in the north.

The Macatawa Area Express (MAX) is the public transit system for the greater Holland/Zeeland area, with fixed route buses serving the City of Holland, City of Zeeland, and Holland Charter Township. MAX also offers Reserve-A-MAX curb-to-curb service for persons with disabilities, seniors, and those whose origins and destinations are farther than ¼ mile of a bus stop. All MAX vehicles are wheelchair accessible and larger buses are equipped with bike racks to enable passengers to take advantage of the area's bike path system.

## **SECTION 3 ADMINISTRATIVE STRUCTURE**

### **CITY MANAGEMENT AND STAFF**

The City of Zeeland operates within a council-manager form of government. The city manager serves as the city's chief administrator. He supervises the implementation of policy and procedures as directed by the city council through coordination and supervision of operations in all city departments. The city manager advises the city council on all matters relating to the planning, development, and operating status of city departments.

### **CITY SERVICES AND INFRASTRUCTURE**

The Parks and Cemetery Supervisor is responsible for the overall supervision of the day-to-day operations. The Supervisor is responsible for managing three full-time Parks/Cemetery Maintenance Workers and up to five seasonal employees. These employees are responsible for the maintenance and care of the City Parks, Cemeteries, and Downtown District including lawn/sprinkler maintenance, playground maintenance, and winter snow removal. The Supervisor reports to the Assistant City Manager, City Manager, Cemetery and Parks Commission, and the City Council.

### **CEMETERY AND PARKS COMMISSION**

The Cemetery and Parks Commission assists the Cemetery and Parks Department in developing policies and procedures. The Commission includes seven (7) members. The seven-member board advises City Council on long-range plans and need for the City's cemeteries.

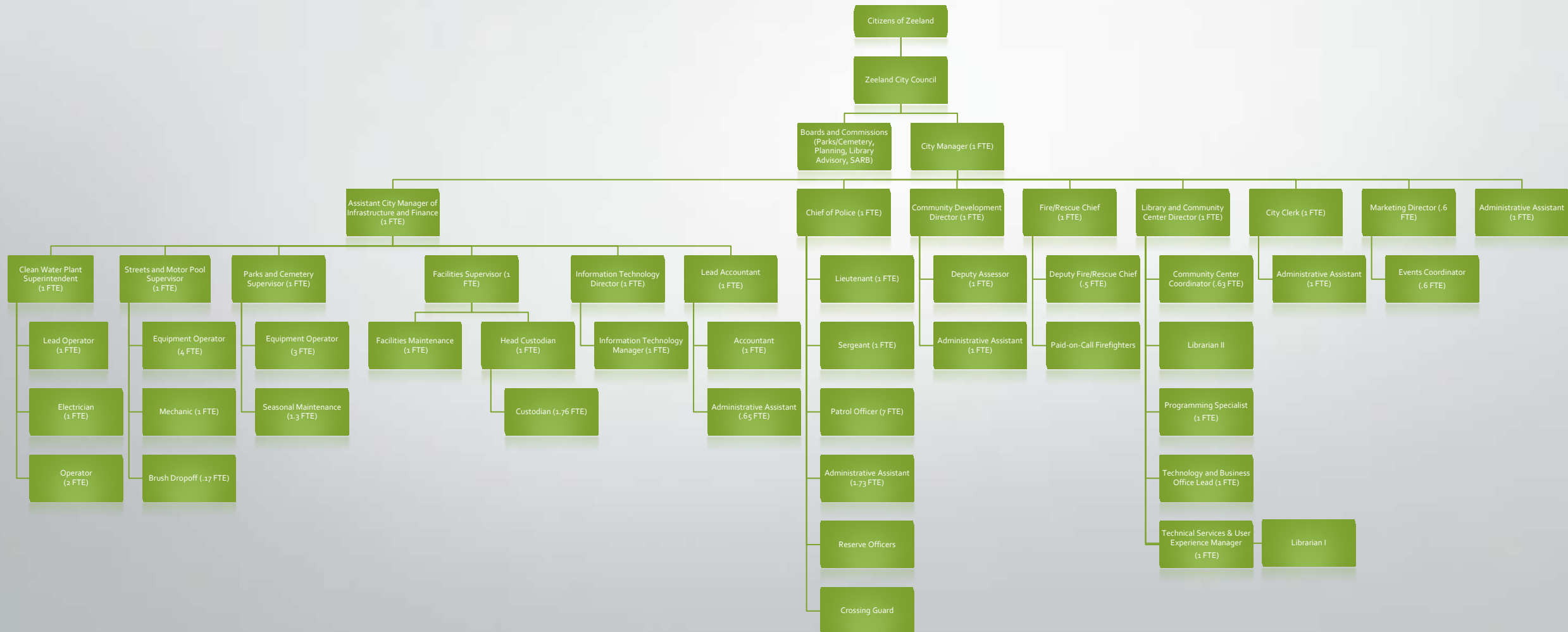
## **CURRENT FUNDING SOURCE**

The parks activity accounts for all care and maintenance of city parks, lawns and landscaping at city buildings, city sign maintenance, and other city owned property encompassing approximately 40 acres. Maintenance includes grass mowing, trimming, watering, leaf raking, landscaping, playground and picnic equipment care, and building custodial services.

The City's vision includes having outstanding city parks for community recreation and gatherings. Large-scale park improvements and new park projects are part of the City Park Improvement Fund.

Included in Fiscal Year 2021-22 budget is funding for the finalization of a 5-year parks master plan to evaluate the condition and establish a capital improvement schedule for all of the city parks and improvements to the VandeLuyter Square Gazebo.

## SECTION 4

### EXISTING RECREATION INVENTORY

In order to determine the recreational needs for the City of Zeeland, an analysis of the existing facilities was undertaken. The intent of the analysis is to provide a clear evaluation of the strengths and weaknesses of the existing recreational opportunities the City has to offer its citizens. The inventory is based on information provided by City staff and site inspections carried out by MCSA Group as part of the planning process.

#### **CITY PARK AND OPEN SPACE FACILITIES**

The City of Zeeland provides a range of passive and active recreation opportunities for residents within its City Parks. There are Nine (9) City parks and trails and five (5) public school sites that have existing recreational facilities on approximately 31.71 acres of public or quasi-public land in the City of Zeeland. The City properties can be classified as follows: one neighborhood park, one community park, five mini parks. This classification is adapted from “Park, Recreation, Open Space and Greenway Guidelines,” J. D. Mertes and J. R. Hall, 1995, as recommended by the Michigan Department of Natural Resources. A more detailed description and photographic inventory of each site follows. An Existing Recreation Facilities map at the end of this section illustrates the location of public park/recreation areas within the City, and an Existing Recreation Facilities matrix provides a summary of the facilities provided at each Location.





An Accessibility Assessment of each facility was undertaken using the following ranking system for the site elements based upon the 2010 Standards for Accessible Design:

- 1 NONE
- 2 SOME
- 3 MOST
- 4 ALL
- 5 THE FACILITY MEETS THE PRINCIPALS OF UNIVERSAL DESIGN  
*Equitable Design, Flexibility in Use, Simple and Intuitive Use, Perceptible Information and Tolerance for Error, Low Physical Effort and Size and Space for Approach and Use*







## **NEIGHBORHOOD PARKS**

Neighborhood parks remain a basic unit of the park system and serves as the recreational and social focus of the neighborhood. This park typically serves a ¼- to ½-mile distance and is uninterrupted by nonresidential roads and other physical barriers. A size of 5-10 acres is considered optimal for this type of park. The focus is on informal active and passive recreational activities, such as walking, field games, court games, playground equipment, and picnicking. The City has one neighborhood Park.





***Lawrence Park***  
***100 W Lawrence Ave***  
***3.2 Acres***

---

This park is located in a mixed-use area in the south-central part of the City. Active recreation facilities at this 3.2-acre site include a ball field, two tennis courts (that are also used for basketball), an informal football field, tennis/pickleball/basketball courts, and a playground area with a component structure and slide, as well as several older swing sets. The park also features an outdoor amphitheater with stage area, known as the “bowl”, which is the scene for a summer concert series and other community events. There is also a large group picnic shelter with attached bathrooms, a community room, and a large group grill area. Open grass areas with mature trees contain additional picnic tables and grills. The park is generally lighted, except for the ball field and tennis courts, and has a small off-street parking area. A stairway links the park to Crestwood Village. A copy of the playground safety inspection checklist is provided at the end of this report.

***Accessibility Rating: 3***

There are several areas of the park that could use accessibility upgrades.

***Accessibility Improvements:***

The site amenities (drinking fountains, benches, grill) and playground equipment should be made accessible. An accessible path could be added to the East side of the park to allow further use.

***Condition:***

This park is very well used and maintained. Site lighting was recently replaced. Basketball goals were added to the tennis courts as well. The tennis courts have been resurfaced. Parking and drives should be repaved, and some playground equipment should be replaced. The Restroom/Concession/Rental/Shelter building has had interior improvements made, but the concrete under the shelter should be replaced. A walking path throughout the park would provide more accessibility.









## **COMMUNITY PARKS**

Community wide parks serve a broader purpose than neighborhood parks and provide a range of facilities and areas capable of supporting structured and unstructured community participation. These areas are typically between 30 and 50 acres in size and serve two or more neighborhoods and a ½ to 3-mile distance. Facilities may include wooded or natural areas, picnic shelters and grills, bike or hiking trails, and other semi-active and passive uses for large groups of people. They may also contain specialized recreational facilities such as swimming pools, community centers, and lighted ball diamonds. Community Parks should be easily accessible from throughout their service area. There is one Community park in this category.







***Huizenga Park***  
***350 Royal Park Dr***  
***23.7 Acres***

---

The City's largest park consists of 14.7 acres and is located south of Business I-196. This community park features a range of facilities including a skate park, four (4) small picnic shelters, a basketball court, three (3) football fields, a sand volleyball court, two (2) softball fields, a restroom building, walking trails, and several paved parking areas. A new playground was installed in 2018 replacing the Timber Towns Structure installed in 1994. The softball fields were renovated in 2021. Pickleball courts were added to the north side of the park in 2019. At that time, the restroom building was replaced with a newer building and an additional shelter and parking area were added. The restroom building near the ballfields has been improved and made fully accessible. The park also features a fishing pond. Connections to the existing trail to make it longer and run the entire perimeter of the park are planned.

***Accessibility Rating: 4***

This park has had many improvements over the last few years, all of which meet the Principals of Universal Design.

***Accessibility Improvements:*** When the remaining items of the park are replaced, they should be made accessible.

***Condition:*** This popular park is well maintained, and in good condition.







## **MINI PARKS**

***Mini-parks*** are specialized facilities that serve a concentrated or limited population or specific group such as tots or senior citizens. The service area of a mini-park is less than a ¼ mile radius and the park size is typically less than 1 acre. The City of Zeeland has five mini-parks.







### ***Michigan Street Tot Lot***

***376 Michigan St***

***0.11 Acres***

---

This park is located in a residential neighborhood. The playground features older play equipment with a surrounding concrete pathway and a small picnic shelter with tables and benches.

#### ***Accessibility Rating: 3***

This park has paved walkway connections to most of the facilities.

#### ***Accessibility Improvements:***

A barrier free connection to the shelter and ramps into the playground should be added.

#### ***Condition:***

The park is very well maintained. Considerations should be made to replace the component structure, track ride and swings as they are at the end of their life expectancy.







## ***Hoogland Park***

***0.54***

***1.1 Acres***

---

This park is located East of the Zeeland Cemetery, in a residential neighborhood, south of downtown Zeeland and north of the I-196 Business Loop. The site features a playground, small picnic shelter, restroom facility, and paved parking area. Recently the City acquired the 0.33-acre adjacent property to the East.

### ***Accessibility Rating: 3***

Some upgrades have been made, but additional improvements need to be made.

### ***Accessibility Improvements:***

Barrier free access to the shelter as well as barrier free ramps into the playground should be provided.

### ***Condition:***

The park is very well maintained. Recent improvements include added fencing to the perimeter of the park. Shelter is showing rust. Considerations should be made to replace the wooden playground equipment and swings as they are at the end of their life expectancy.







***Vande Luyster Square Park***  
***148 E Central Ave.***  
***0.85 Acres***

---

This park is located at the intersection of Central Avenue and Church. It has fountains, walkways, and benches set amongst mature trees with a memorial dedicated to Janne Vande Luyster, founder of Zeeland. Features include a small gazebo and a time capsule installed in 1976 and due to be opened in 2076. There are paved walkways through each part of the park linking to the City sidewalk system.

***Accessibility Rating: 4***

There are a few brick walks that need repair to be flush.

***Accessibility Improvements:***

Provide paved companion spaces at some of the benches.

***Condition:***

The park is very well maintained. The pavilion is showing signs of age and should be replaced.







***Paw Paw Park***  
***1099 Paw Paw Drive***  
***1.5 Acres***

---

This park is located at the west City limits. It has a winding bike path and a footbridge spanning the Macatawa River. A shelter with picnic tables are also provided.

***Accessibility Rating: 2***

Most of the walks do not meet barrier free requirements.

***Accessibility Improvements:***

All existing pathways should be removed and replaced with those that are ADA accessible. Access to the Macatawa Greenway Interpretive signage should be added.

***Condition:*** The park is well maintained. Shelter and Bridge are in good shape.





***Splash Pad Park***  
***S. Elm Street***  
***0.25 Acres***

---

This park is in the previous location of Heritage Square at the intersection of Main and Elm bordered by City Hall. There is a paved plaza with and outdoor fireplace, splashpad with shade shelters, seating, a drinking fountain, and a plaque on Zeeland's Dutch Heritage.

***Accessibility Rating: 5***

The park, as well as the adjacent streets, all meet Universal Design Standards.

***Accessibility Improvements:***

None required at this time.

***Condition:*** The facility is in excellent condition.







***Elm Street Park/ Skating Rink***  
***21 S. Elm Street***  
***0.12 Acres***

---

This park is located at the corner of Elm and Cherry. This mini park has seating and lawn games in the summer and a synthetic skating rink in the winter. This is also the location of the Farmers Market.

***Accessibility Rating: 5***

The park, as well as the adjacent streets, all meet Universal Design Standards.

***Accessibility Improvements:***

None required at this time.

***Condition:*** The facility is in excellent condition.







## **TRAILS**

Trails can also provide both transportation and recreation independent right-of-way, or within the road right-of-way. Connector trails are defined as “multi-purpose trails that emphasize safe travel for pedestrians to and from parks and around the Community” (J.D. Mertes and J.R. Hall, Park, Recreation, Open Space and Greenway Guidelines, 1995). These trails are generally located within the road right-of-way and can be divided into two types. Type I has separate paths for different user types, such as pedestrians and bicyclists. Type II has mixed uses and is suited to lighter use patterns.

### ***Eastside Pathway***

### ***Northside Pathway***

1.5-mile non-motorized pathway that runs from State Street/96<sup>th</sup> Avenue to Fairview Avenue. The path travels along the Boone Drain, which offers views of natural waterways, wetlands, and woodlands. The path is lighted and bike and wheelchair accessible. A gazebo and benches are provided.





### ***Shared Use Pathways***

These are located throughout the City linking residential areas with schools and recreation facilities. The central area of the City has a good network of sidewalks, with bike paths leading from the City north to Riley Street and south to Perry Street, linking with Zeeland three and Holland Charter Township bike paths. A map illustrating the existing sidewalk and bike path system is included in this plan section.

### **INDOOR RECREATION FACILITIES**

Zeeland Community Recreation Center is operated by Zeeland Recreation (Zeeland Public Schools). Zeeland Recreation provides a comprehensive program of activities including youth, adult, and senior activities, as well as aquatic programs and special events.



### **REGIONAL FACILITIES**

The regional recreational resources located in close proximity to the City of Zeeland are described below.





**Hemlock Crossings/Pine Bend (Ottawa County)** is 239 acres of woods and wetlands along the Pigeon River in Port Sheldon Township just west of US 31. Facilities include two small picnic shelters, a kayak/canoe launch, over a mile of paved trail, and over 6 miles of trails for hiking and cross-country skiing. A pedestrian bridge and numerous overlooks offer scenic views of the river corridor, wetlands, natural springs, and woods. Pine Bend is a secondary access on the west end of the property that offers parking and a trailhead. Future plans include the development of a Nature Center at this site.

**Holland State Park (State of Michigan)** is located eight miles west of Holland. It offers an expansive sandy beach along Lake Michigan and 342 modern campground sites. The park is divided into two separate units: one along Lake Michigan and the other along Lake Macatawa. A day-use area has picnic facilities, playground equipment, restrooms, and a beach shelter and concession. The beach day use area of the park is open year-round.

**Kirk Park (Ottawa County)** consists of 68 acres of sandy beach, high bluffs, and wooded dunes on the Lake Michigan shoreline in Grand Haven Township. This park offers a lodge and picnic shelter, swimming beach, limited play equipment, and natural trails with a lake overlook deck. Dogs are allowed on the beach at Kirk Park which draws a lot of users.

**Saugatuck Dunes State Park (State of Michigan)** in Allegan County is a day use park along Lake Michigan, offering 1,000 acres of land with two- and one-half miles of shoreline. In addition, the park has fresh water coastal dunes that are over 200' tall. The park is relatively undeveloped, with a picnic area, swimming beach, and hiking trails. In the winter there are 13 miles of un-groomed cross-country ski trails.

**Silver Creek Park (Allegan County)** is primarily a horseman's park with day use facilities, primitive camping, equestrian trails, and fishing opportunities on 450 feet of Silver Creek, a spring fed trout stream. The 320 acres of wooded land on 134<sup>th</sup> Avenue is open year-round.

**Spring Grove Park (Ottawa County)** has 16 acres in Jamestown Township that offers picnic facilities, including a fully enclosed picnic building, a flowing spring and small natural area, and a trellis designed for outdoor weddings and other ceremonies.

**Tunnel Park (Ottawa County)** is a 22-acre park situated on the shores of Lake Michigan in Park Township. In addition to the unique tunnel through a dune, this park has a children's



playground, a dune climb, a dune stairway with scenic views of Lake Michigan, swimming, and picnicking opportunities.

Other State land in the vicinity includes the **Allegan State Game Area**. This covers 50,000 acres of public land providing hunting, fishing, rustic and group camping, hiking, equestrian, snow-mobile, and cross-country ski trails.

The surrounding urban areas of Holland, Grand Rapids and Grand Haven, also offer significant regional facilities to area residents.

### **DNR RECREATION GRANT INVENTORY**

The City of Zeeland received two grants administered by the Michigan Department of Natural Resources. One for Huizenga Community Park (PF89-526). A development grant was awarded in the amount of \$94,325.00. A fishing pond viewing deck, two (2) fishing boardwalks, two (2) tennis courts, a playground, two (2) restrooms with water service, a pavilion, a volleyball court, soccer/sports field, and passive area were constructed. The second grant (TF150065) was for the expansion of the existing splash pad in 2015. The project included a shelter and additional site amenities.





## **CITY OF ZEELAND SCHOOLS**

There are five (5) schools on 47.33 acres in the City of Zeeland. A number of these properties provide venues for both outdoor and indoor programs offered by Zeeland Recreation.

***Early Childhood Center*** is located on McKinley in the west of the City of Zeeland. The limited outdoor space includes a playground with some paved pathways between structures. Some of the equipment needs updating.

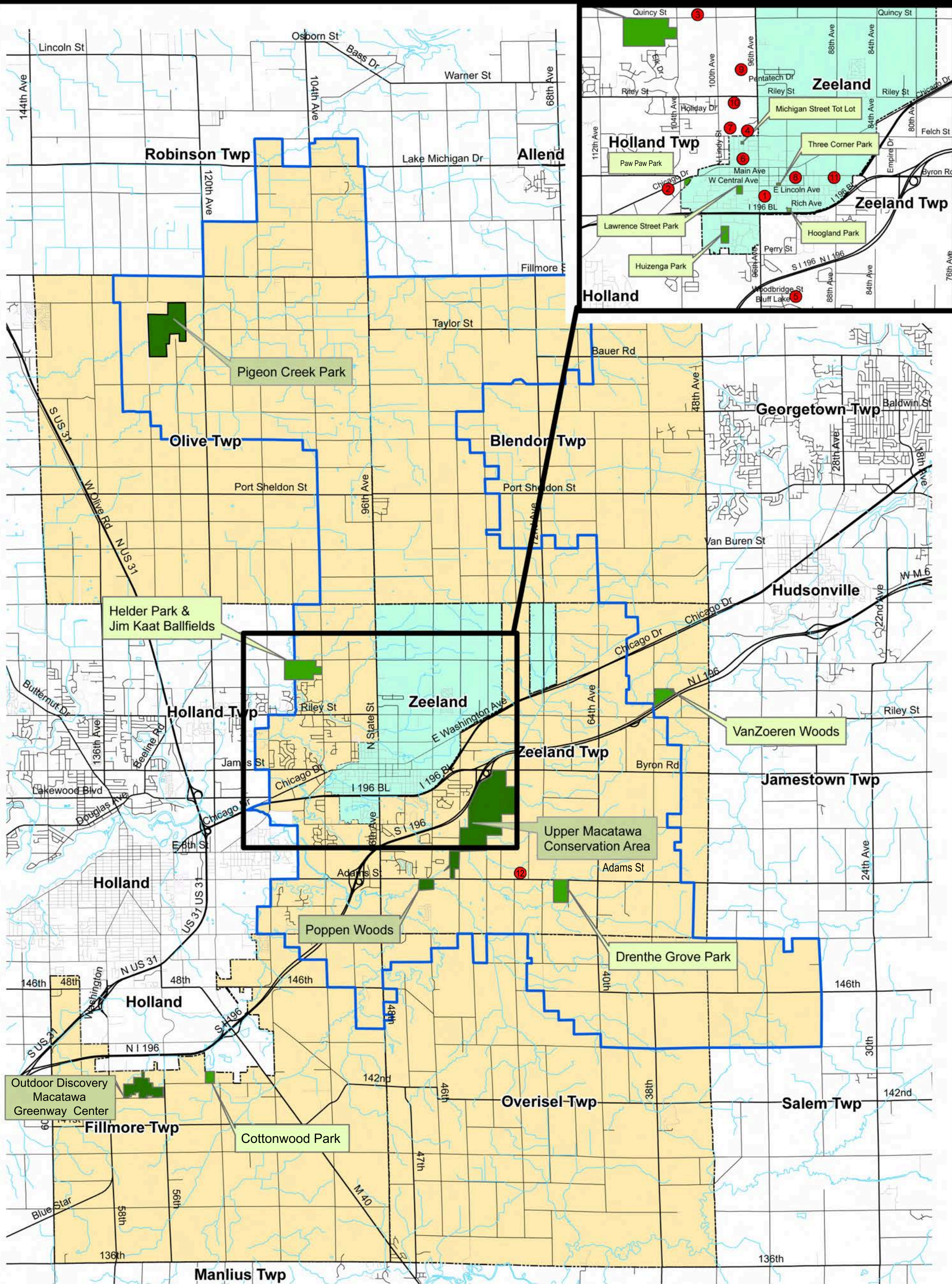
***Lincoln Elementary School*** is in a residential area in the south-central part of the City of Zeeland. This 10-acre site includes two playground areas; two (2) basketball areas; two (2) small size soccer fields and a ball field. There is also some paved recreation space adjacent to the school. The condition of the facilities varies considerably, but in general there is good variety of play and recreation opportunities.

***Cityside Middle School*** is located on the east side of Downtown Zeeland. It has no significant outdoor recreation facilities, with outdoor recreation space provided by the recreation area at Main and Fairview. However, there are a range of indoor facilities, including the Zeeland Community Recreation Center that offers a community pool, auditorium, cardio-fitness center, and activity rooms.

***Main and Fairview*** is a 15-acre site in the east side of the City. The site is used as the outdoor recreation space for Cityside Middle school and other programmed activities. Facilities include one softball and one baseball field, one informal and one formal soccer field, and limited parking. The west end of the site houses Zeeland Public Schools bus garage.

***Zeeland Christian School*** is in a residential area in the south of the City of Zeeland. There is some older play equipment and exercise stations with pea-stone surfacing; four basketball hoops; a paved play surface with a ball wall and a shade shelter with picnic tables, restroom, and concession/storage area on the upper area adjacent to the school building. The lower area features a large open playing field, softball field, baseball field, three (3) small soccer fields and one (1) full-size field, all of which are irrigated. The grassy slope between the two levels is used informally as a sledding hill.

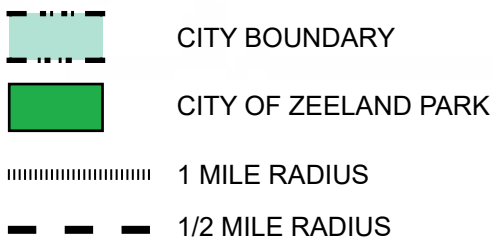

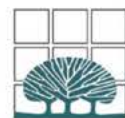

## **SECTION 5 PLANNING AND PUBLIC INPUT PROCESS**

### **RECREATION PLANNING**

Recreation planning plays an important role in maintaining the quality of life in a community. If a community is to provide effective recreational opportunities, it needs a way of identifying and solving current problems and anticipating future needs. Recreation planning is one means of obtaining a perspective on these problems; developing realistic alternatives; formulating goals, policies, and recommendations for public and private decisions; developing criteria to measure change; and involving people in the planning, design, and decision processes.

This Parks and Recreation Plan presents an evaluation of the City's recreational needs and opportunities. It considers the existing amenities in the City, the current and anticipated demand for additional or improved facilities, and the means for providing those facilities.

This plan is to serve as a guideline for directing the City in the operation and maintenance of existing and future facilities and programs to meet the recreational needs of its citizen's. The plan summarizes long-term recommendations intended to guide the development of recreation opportunities and describes an action and capital improvement program for implementation over the next five years.

### **PLAN PROCESS AND DEVELOPMENT**

This 2021 Community Park and Recreation Plan was developed by the City Zeeland, with the assistance of MCSA Group, Inc, a park and recreation planning consultant. City staff met regularly with representatives of MCSA Group, between August 2020 and February 2022 for the development of this Plan.

Criteria considered and evaluated for plan development evolved from the examination of goals and recreation standards determined through a wide variety of input sources. This information was collected from the inventory and review of existing facilities; the identification of recreation needs and deficiencies; public opinion; current statewide recreation issues and priorities; and future expectations.



Public input was sought throughout the process by means of a series of open Public Meetings held to solicit public desires and concerns regarding parks and recreation. The meetings were held in conjunction with the regularly scheduled meetings of the Cemetery & Parks Department. They were advertised via Email, on the City's website, social media and in the local media. The meeting schedule was as follows. A summary of the comments and discussion items can be found in the appendices of this report.

In addition, the City undertook a survey of City residents. The survey was available on the internet via Survey Monkey, as well as printed copies at the Recreation Department, Library and City Hall. A total of 429 surveys were completed, approximately 7.75% of the households. A copy of the survey and a summary of the results are included at the end of this section.

The survey was well received and indicated a high level of satisfaction with the City's Park and Recreation system. Many respondents recorded an interest in increased Restroom Facilities. Of the City's recreation locations, Huizenga Park is the most frequented, with Lawrence Park, Splash Pad Park, and Paw Paw Park also well used. Michigan Street Tot Lot and the Northside Parkway trail are the least visited City Parks. The maintenance of Zeeland parks was rated as "Excellent" or "Good" by most respondents (73.1 %).

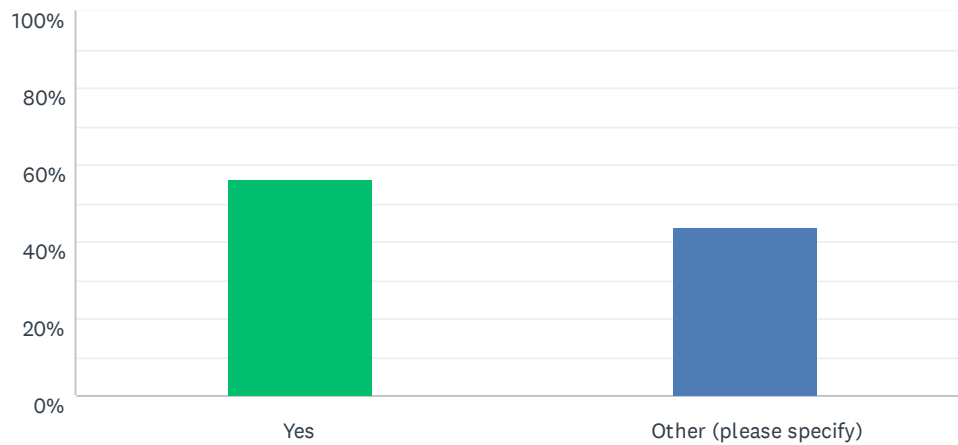
Another important part of the planning process was the development of concept plans for each of the major park properties. These were presented at the public meetings and were made available for viewing on the City's website. The plans were generally well received. The City responded to comments made and refined the plans, as necessary.

Comments from the public meetings and surveys were incorporated into a final draft of the Plan, which was made available to the public for one month commencing on September 13, 2021 to solicit further comments prior to a public hearing and plan adoption.

Following the one-month review period, the final plan was presented during a public hearing to the City Council on January 25, 2022. The Resolution to formally adopt this plan can be found in Section 9.

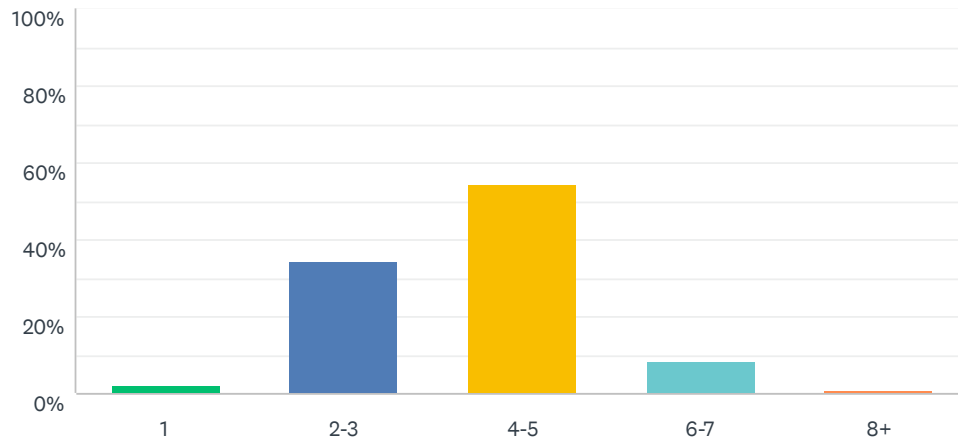

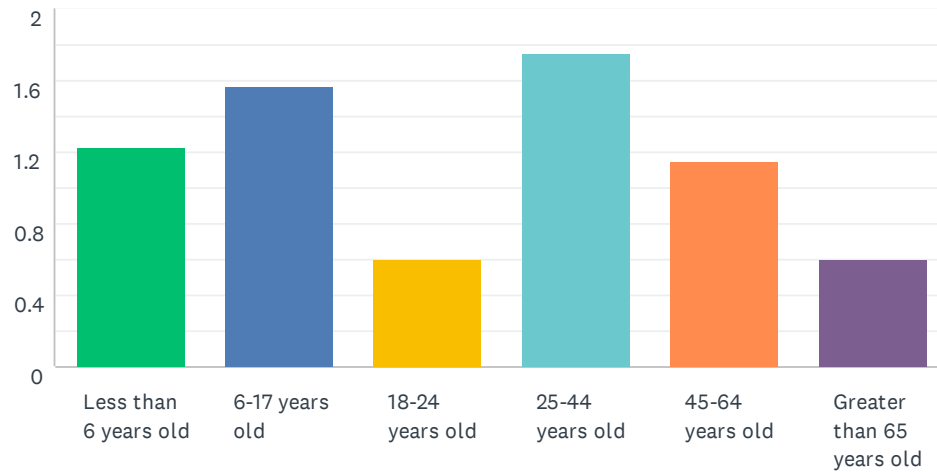

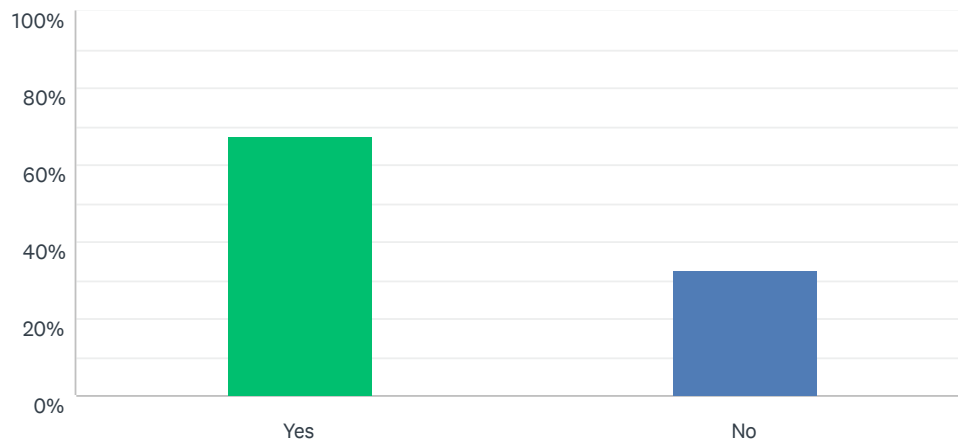

## Q4 Have you or members of your household participated in recreation programs offered by the City of Zeeland in the last 12 months?

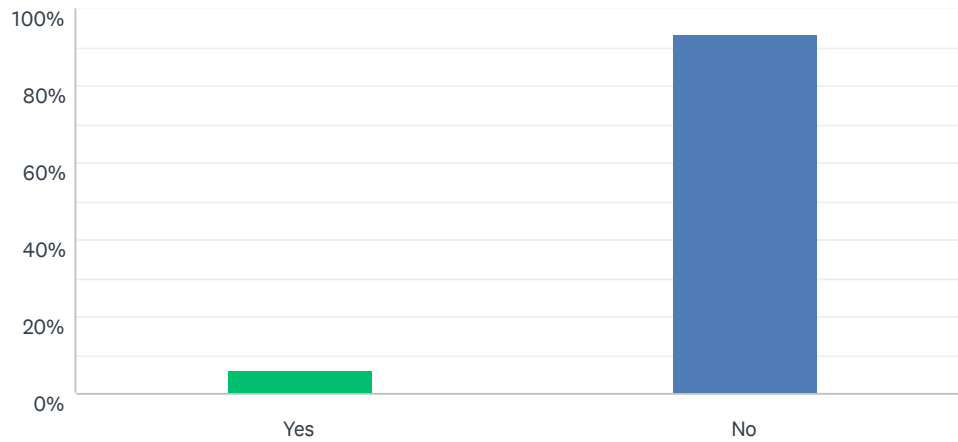

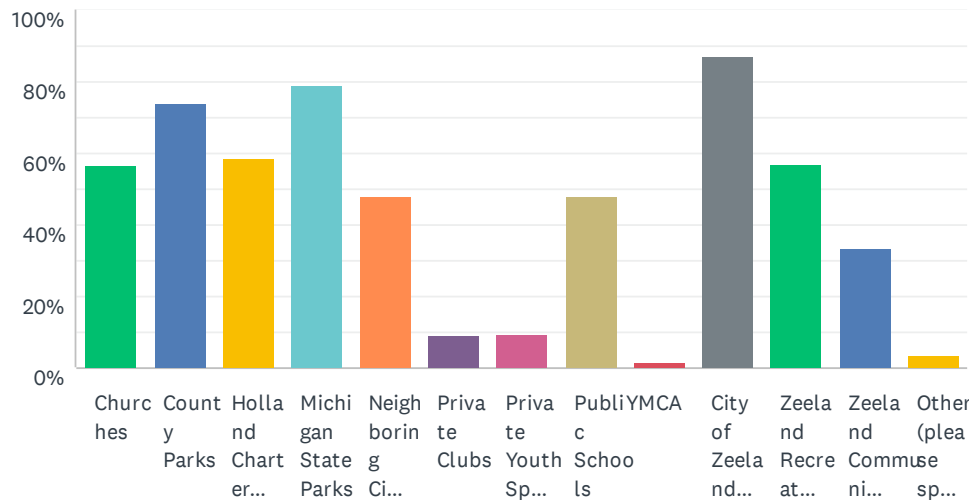

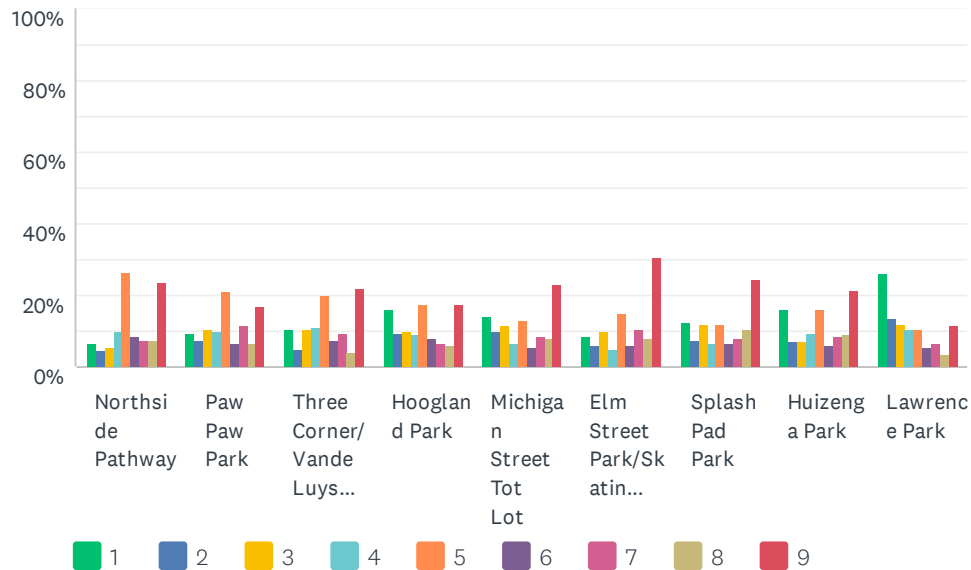

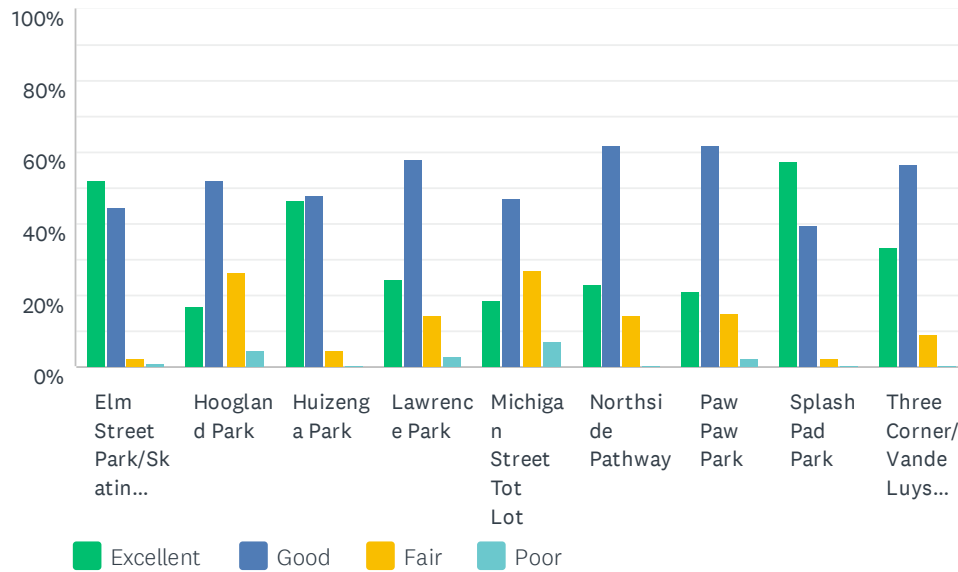

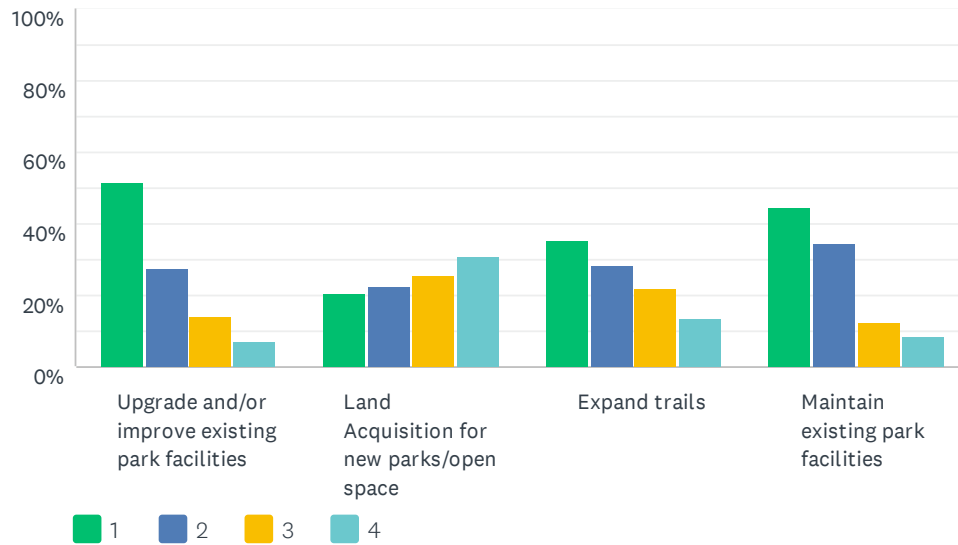

## SECTION 6

### RECREATION NEEDS AND DEFICIENCIES

This section of the Plan identifies recreation deficiencies determined through a variety of means. Study methods include comparison to recreational standards for acreage and facilities, geographic distribution of existing facilities, direct input from City staff and representatives, and public input and participation. While each of these methods has its limitations, using a combination of methods will yield a more accurate assessment of recreational needs and deficiencies. The following is a brief description of each of the methods used.

### RECREATION STANDARDS

While only a guide, recreation standards provide a benchmark for evaluating the relative adequacy or inadequacy of the City's recreation system. This Plan has used as a guide the 1983 Recreation, Park, and Open Space, Standards and Guidelines and 1995 Park, Recreation, Open Space and Greenway Guidelines published by the National Recreation and Park Association.

Typical recreation standards establish a certain number of activity-specific recreational facilities per 1,000 of population (e.g. 1 tennis court per 2,000 persons). Other standards establish a certain number of acres per 1,000 of population for different types of park facilities, such as neighborhood, community and regional parks. These standards are adapted to reflect the City's character and compared with the City's existing and projected population. This Plan will combine both approaches to ascertain deficiencies in recreational facilities and acreage. The 2019 U.S. Census Bureau population estimate was used for the purposes of this study.

There are two basic types of recreational experiences: "active" and "passive." "Active" recreation requires space and facilities capable of accommodating exertive activities. Such facilities include: sports fields, play apparatus areas, open areas, special facilities, such as pools and court areas, and areas for organized activities. On the other hand, "passive" recreation requires little more than space and furniture for quiet, non-exertive activities for limited numbers of users. Recreation areas must provide for both types of use and preferably include a variety of opportunities for each to respond adequately to a wide range of interests and age groups.





Parks are generally classified by purpose and area per population served. They range in type from mini-playlots and green areas to large regional and national parks.

The categories used for this plan will be as follows:

1. Neighborhood Parks and Schools
2. Community Parks
3. Natural Resource Areas
4. Trails

## RECREATION STANDARDS FOR ACREAGE

### 1. Neighborhood Parks and Schools

**Description** - Neighborhood parks serve individual neighborhood populations as determined by the distance that can easily be traveled by local users for relatively short periods of recreation. Facilities provided in these parks are generally active in nature and include multipurpose open play areas for pick-up games, play apparatus, court areas, landscaping, site furnishings and possibly a shelter. Special areas for bike riding or specific court games may also be provided. Activities for all seasons should also be included.

**Service Areas** - The area served by neighborhood parks is generally considered to be a one quarter (1/4) mile to one half (1/2) mile radius in size and should be uninterrupted by non-residential roads or other physical barriers.

**Neighborhood Park Acreage Standards** - Nationally accepted standards for neighborhood parks recommend one to two (1-2) acres per 1,000 of population with five (5) acres as a minimum size and five to ten (5-10) acres optimal. It is recommended that the minimum of two (2) acres per 1,000 population be used as a guide for site selection.

It is also recommended that neighborhood facilities be combined with elementary schools. In such cases, the minimum site size should be five to seven (5-7) acres.



### ***Existing Recreation Acreage***

The City of Zeeland currently has six (6) parks that would fit into the neighborhood park definition.

***Needs and Deficiencies:*** The table below compares the 2019 City population to the recreation standard of two (2) acres per 1,000 persons.

For the 2019 population, there is an excess of 20.65 acres for neighborhood recreation in accordance with the recreational standards. This neighborhood recreation space is comprised almost entirely of school properties. The school sites generally provide a range of recreational facilities. However, improvements are needed to improve accessibility and to update the facilities offered.

The use of the acreage standard must be coupled with a review of the location and accessibility of the existing recreation areas. Ideally, they should be centrally located and parks and schools should be adjacent to each other to provide the fullest complement of neighborhood recreation developments. Additionally, the recreational acreage should be accessible on foot without having to cross busy streets or negotiate physical barriers.

Most of the City is adequately served by neighborhood parks when considering the utilization of school sites. Although, the northeast side of the City, appears to have a deficiency in neighborhood parks.

## 2. Community Parks

**Description** - Community-wide parks provide a range of facilities and areas capable of supporting organized community participation programs that would not be appropriate in neighborhood parks because of their average size or traffic volume generated. Facilities should be centrally located, diverse enough to accommodate all age groups for both active and passive experiences and organized so that compatible uses relate to one another. Adequate parking and vehicular circulation is also important, since park users will generally arrive at these parks by vehicle. Lighted use areas significantly increase the recreational value of parks of this type. Typical facilities recommended for community parks include ball fields, open use areas, tennis courts, picnic areas, play apparatus areas, restrooms and shelters. Additional special facilities could include band shells, amphitheaters, swimming and wading pools, community-meeting buildings, skating facilities, bicycle courses and nature study areas.

As with neighborhood parks, it is often beneficial to develop community parks in conjunction with junior or senior high schools where practical because of the athletic fields and courts potentially available for public use. This arrangement assures the maximum level of use as well as the most practical expenditure of development funds.



***Service Area*** - The area served by community-wide parks varies significantly from one municipality to another because of the distribution of population and related factors. However, a community park usually serves two or more neighborhoods and ½ to 3 mile distance.

***Community Park Acreage Standards*** – The size of a community park varies according to the desired uses but is usually between 30 and 50 acres. It is recommended that a range of five (5) to eight (8) acres per 1,000 population be used as a standard basis for development.

***Existing Community Recreation Acreage*** – The City of Zeeland has one (1) facilities which would fall within the City-Wide Community Park classification.

The City-Wide Community Park developed acreage of 23.7 acres is deficient by 20.59 acres from the considered national standard for a typical community of this size based upon 2019 population.

### **3. Natural Resource Areas/Open Space**

***Description*** - Natural Resource Areas are lands set aside for preservation of significant natural resources, remnant landscapes, open space and visual/aesthetic buffering. These sites are typically unsuitable for development but offer natural resource potential and can support recreational activities at a level that preserves the integrity of the natural resource. The location and size of these parks are largely governed by availability.

***Existing Natural Resource Area Acreage*** – There are currently no natural resource areas in the City of Zeeland.





***Needs and Deficiencies*** - There are no recognized acreage standards for natural resource areas.

#### **4. Trails**

***Description*** – There are a number of different types of trails that can provide both transportation and recreation opportunities. Trails may be located within parks, on an independent right-of-way, or within the road right-of-way. Connector Trails are defined as “multi-purpose trails that emphasize safe travel for pedestrians to and from parks and around the Community” (J.D. Mertes and J.R. Hall, Park, Recreation, Open Space and Greenway Guidelines, 1995). These trails are generally located within the road right-of-way and can be divided into two types. Type I has separate paths for different user types, such as pedestrians and bicyclists. Type II has mixed uses and is suited to lighter use patterns.

In park trail systems within the City of Zeeland are limited, with the most developed systems provided at the larger County owned facilities. However, the one non-motorized path and a network of shared use pathways helps provide the community with trail use options.

##### ***Northside Pathway***

1.5 mile non-motorized pathway that runs from State Street/96<sup>th</sup> Avenue to Fairview Avenue. The path travels along the Boone Drain, which offers views of natural waterways, wetlands and woodlands. The path is lighted and bike and wheelchair accessible. A gazebo and benches are provided.

##### ***Shared Use Pathways***

Throughout the City linking residential areas with schools and recreation facilities. The central area of the City has a good network of sidewalks, with bike paths leading from the City north to Riley Street and south to Perry Street, linking with Zeeland Township and Holland Charter Township bike paths. A map illustrating the existing sidewalk and bike path system is included in this plan section.

***Needs and Deficiencies*** - There have been no deficiencies determined for this category and needs vary depending on the community. Any future trail improvements should be integrated with other regional trail networks to create an interconnected trail system where possible.





## RECREATION STANDARDS FOR ACTIVITIES/FACILITIES

A comparison of activity-specific recreational facilities within the City of Zeeland to recreation standards indicates that the City contains many of the recreational facilities desirable for the current population.

The following table compares the recommended number of facilities per population for the City of Zeeland with the existing facilities available and illustrates any current or projected deficiencies.

Little League fields show the biggest need, since there are none within the city at either parks or schools. Also showing deficiencies are Tennis and Volleyball courts with only two (2) of the recommended three (3) tennis and one (1) of the recommended two (2) volleyball courts provided in the City.

While standards for comparison address the quantity of facilities desirable for a particular number of persons, they do not address quality or location concerns. Consequently, any community that has the appropriate numbers of facilities may not have facilities of a useful or desirable quality or may not have facilities located where they would be most accessible to residents.

## RECREATION FACILITIES SUMMARY

The City of Zeeland takes pride in its park and recreation facilities and demonstrates good stewardship of its natural resources. While substantial improvements have been achieved over the last 10 years, a variety of improvements are recommended to fully utilize the City's recreational land and improve accessibility for all users.

## SECTION 7 GOALS AND OBJECTIVES

The City of Zeeland has developed the following goals and objectives for park and recreation facilities and programs. These Goals and Objectives are based upon input from citizens, elected and appointed city officials, and city staff. The goals are long-range in nature and intended to be broad in scope and flexible enough to accommodate future change. The objectives are intended to direct specific program and development decisions to be made within the next five years. Both the goals and objectives are intended to guide actions but flexible enough to reflect changing attitudes and opportunities as may present themselves. Time and attitude changes can impact on specific options and it is essential for the City of Zeeland to be responsive to its citizens.

### ***PROVIDE A BALANCED SYSTEM OF PARK AND RECREATION FACILITIES IN THE ZEELAND AREA WITH OPPORTUNITIES AND PROGRAMS FOR RESIDENTS OF ALL AGES AND ABILITIES.***

#### **Objectives:**

- Continue to maintain the high quality of existing parks.
- Acquire and develop land for parks to serve existing and future residents.
- Plan and develop park areas to offer passive as well as active opportunities.
- Renovate and improve existing park sites to meet and exceed all safety and accessibility regulations.
- Continue to provide quality programs that will allow recreation to be a fulfilling experience and promote healthy lifestyles for all residents, regardless of race, religion, income, and ability.

### ***EXPAND THE DIVERSITY OF RECREATION FACILITIES AVAILABLE TO OFFER YEAR-ROUND OPPORTUNITIES TO MEET CURRENT AND FUTURE DEMAND.***

#### **Objectives:**

- Meet the demand for active sports facilities to support the need in the community.
- Expand opportunities for year-round recreation activities.



- Expand opportunities for passive recreation and un-programmed activities, such as picnic facilities, walking trails, fishing and wildlife viewing.

***CONTINUE TO PROVIDE NATURAL, SCENIC OR ENVIRONMENTALLY SENSITIVE AREAS FOR APPROPRIATE PUBLIC USE AND ENJOYMENT AND HABITAT PROTECTION.***

**Objectives:**

- Acquire environmentally sensitive land such as riverfront, waterfront and wetland property as it becomes available.
- Manage and enhance environmental areas to protect water quality and natural habitat.
- Design parks to encourage appropriate public use and to minimize impact to important natural features.
- Provide environmental and historical education opportunities as appropriate.
- Provide accessible opportunities at existing scenic and environmentally sensitive areas.

***PROMOTE AND MAINTAIN STRONG WORKING RELATIONSHIPS BASED ON COORDINATION AND SUPPORT WITH THE SCHOOLS, SURROUNDING COMMUNITIES AND BODIES OF GOVERNMENT, AND PUBLIC AND PRIVATE ORGANIZATIONS***

**Objectives:**

- Work with, encourage and support all community, school system and municipal groups, organizations, and agencies to promote and expand recreation opportunities and programs for all age groups in all areas of Zeeland in an efficient and coordinated manner.
- Work cooperatively with adjacent communities to provide joint facilities and connections between park systems.
- Mutually utilize recreation facilities and resources to minimize deficiencies.
- Encourage philanthropic and other non-tax financial support for parks and recreation facilities.





***FOCUS ON PROGRAMS AND POLICIES FOR FURTHER EXPANSION OF THE PARK SYSTEM THROUGH CONTINUED ACQUISITION.***

**Objectives:**

- Secure land for recreational use in areas of residential growth.
- Strive to maintain and improve the quality and character of valuable natural resources for current and future generations through land acquisition.
- Acquire land adjacent to existing park properties to further increase the recreational facilities offered.

***STRIVE TO CONNECT RECREATIONAL FACILITIES TO SCHOOLS, RESIDENTIAL AREAS AND TO ONE ANOTHER WITH NON-MOTORIZED TRAILS THAT PROVIDE SAFE, AND ACCESSIBLE RECREATIONAL EXPERIENCES.***

**Objectives:**

- Develop trail systems within existing park lands.
- Maintain and continue to expand existing bike path and sidewalk system.
- Construct additional bike path segments from existing system to all future acquisitions.
- Connect recreation facilities to schools, residential areas, and to one another with multi purpose paved trails.





## SECTION 8 ACTION PROGRAM AND CAPITAL IMPROVEMENT SCHEDULE

### ACTION PROGRAM

The Action Program and Capital Improvement Schedule for the City of Zeelands' Community Park and Recreation Plan states the proposed course of development or improvement that will be taken over the next five years. The Goals and Objectives, from the previous section, serve as guidelines for the development of the Action Program. The Capital Improvement Schedule which follows will focus on the needs identified in the Action Program and will project potential expenditures for the five-year action period on a year-by-year basis. The five-year period will begin in 2022 and extend through 2026. This period will not be sufficient to accomplish all the goals and objectives but begins to prioritize those projects that may be achievable within the initial five years.

The Action Program focuses on reduction of deficiencies and expansion and improvements of facilities in a manner that not only meets current needs, but also diversifies the type and quality of recreational opportunities within the City. The Community Park and Recreation Plan identifies these needs in general terms in the Recreation Needs and Deficiencies section; the Action Plan describes specific actions to be taken to address these needs; and the Capital Improvement Schedule specifically itemizes those projects which will be most feasible during the next five years. The proposed schedule will allow for flexibility as funds become available and as opportunities are presented.

The following actions are comprehensive and will require more than five years to complete. Master Plans illustrating the proposed improvements are included for each park.

#### ***Lawrence Street Park***

The improvements will be in two phases. The first phase will include removal and replacement of the playground and improvements to the access to the restrooms. Phase Two improvements will include improvements to the parking, improved accessibility at the ballfields, a walking trail and replacement of the multipurpose courts.



### ***Hoogland Park***

Extensive renovations a Hoogland Park will extend the park east to S Maple Street. Improvements include a new playground, restroom improvements, parking improvements a bocce ball court and new shelter

### ***Paw Paw Park***

Improvements to this park include replacement of the accessible route to the Macatawa Greenway Trail, and a Timber Viewing Platform

### ***Huizenga Park***

This Park has had many improvements over years. Phase three improvements will include the addition of four more pickleball courts, pathway connections, fishing access improvements, shade for the new playground, removal and replacement of the basketball court and skate park.

### ***Vande Luyster Square Park***

Phase one improvements at this park will include the removal and replacement of the gazebo with one that matches the architectural character but is lower maintenance. Phase Two improvements include entry columns, a drinking fountain and improvements to the brick pavers

### ***Michigan Street Tot Lot Park***

Improvements to this park include a new shelter, new playground equipment, entrance improvements and a new drinking fountain.



## CAPITAL IMPROVEMENT SCHEDULE

*As stated in the Action Program, improvements and development will occur as funds and opportunities evolve. Assistance will be solicited from all available sources and will include both physical and financial support.*

*The City will take maximum advantage of any job training and related work programs to assist in clean-ups and basic miscellaneous construction and general recreation facility maintenance projects. The City will also seek funding assistance from all available sources such as trusts, charitable foundations, private contributions, and all Federal and State funding programs.*

*The following schedule is a breakdown of the anticipated projects and projected funding for the next five years. Projections are based upon order-of-magnitude 2021 costs and will be detailed with refined programs and plans. Changes in the program may occur if projected funding levels increase or decrease but it is anticipated that the changes would be related more to adjustments in the time schedule rather than specific projects themselves. Refer to the following site concept plans for more site-specific information.*

**1. LAWRENCE PARK**

- Like old growth trees, proposed improvements should keep existing trees.
- Low level area at east end of park gets used for activities. It was requested to adjust the crushed stone trail so that the area remains open.
- Keep grills in low area at east end of park.

**2. Vande Luyster Square**

- Keep all historical signage as is in the park. Note there is new sign recently installed.
- One resident did not know that the southeast corner was part of the park, they thought it was private property.
- Consider moving the gazebo slightly to align with water feature across the street.

**3. PAW PAW PARK**

- Consider a Monarch Waystation in the natural area along the creek. This would require the planting of milk weed and educational signage. For more information see attached provide report.
- Improve natural floodplain area with native plants that are shorter so that there are more open views to the bridge from Chicago Drive.
- Improve the lighting of the bridge to be nicer and dark sky compliant.
- Clarification, timber steps are boardwalk steps and decks.
- Consider widening water access steps and making the trail more curvilinear.
- Numerous people comments that they approve of the idea of correcting the switchback trail to be less steep and meet ADA guidelines.
- Landscaping should address areas that have erosion.



**4. Northeast Trail**

- Please add a drinking fountain/bottle filler someplace along the trail.

**5. General Comments**

- Consider adding a Dino digging pit (Sand Play) in one of the parks.
- Include dog poop bad dispensers and trash cans at all parks.

- Adding sand volleyball courts (16% of responses)
- Adding shuffleboard courts (10% of responses)

- Adding more pickleball courts (dozens of written in comments)

I am excited about the enhancements that are being made at Lawrence Street Park. My family just moved from Lawrence Street five months ago. Bummer!

I am reaching out in regards to the use of the pickleball/tennis/basketball courts. Currently, there are two basketball hoops that are side by side. I am wondering if there is an option to put two more hoops up on the opposite ends so that there are two full courts there? As of right now, I can only think of one full court at a public park in Zeeland which is across the street from Gentex. This location often has 40-50 players for the two baskets. The wait between games can be between 45 min and 1.5 hours.

As the varsity basketball coach for Zeeland West, I would love to see more locations for kids to play. The number of youth participating in our camps at East and West have increased from about 150 athletes total per session for both schools to almost 350 per session. We would like to keep this enthusiasm going and adding a couple quality baskets in order to create two more full courts in a district that serves 6,000 students there is a great opportunity to do that.
